

## **PROSPECTS OF INTERACTION OF YOUNG SCIENTISTS WITH NON-GOVERNMENTAL ORGANIZATIONS IN THE CONDITIONS OF GLOBALIZATION**

*Abstract.* Globalization intensifies the activities of different economic entities. Public (non-governmental) organizations are becoming increasingly important in countries. Collaboration of young scientists with such organizations provides additional opportunities in the early stages of their careers.

Currently, public (non-governmental) organizations play an increasingly important role in the public life of countries according to global social trends [1]. It is important also for young researchers activities. Besides active cooperation with public authorities, young scientists can cooperate with All-Ukrainian and international non-governmental organizations active in Ukraine to solve their problems.

The civil society organizations can help in solving issues related to the realization of certain goals of the Young Scientists Councils, in particular:

- "elaboration of proposals for the creation of legal and socio-economic conditions for attracting young scientists to work in various scientific fields, stimulation of professional activities of young scientists, promotion of their professional level and implementation of their creative and professional activity; advisory support of young scientists in carrying out scientific activities, cooperation with foreign buyers of scientific products, etc.;

- Support in attracting young scientists to participate in competitions for scientific works, formation of teams of young scientists for the implementation of perspective scientific projects;

- Support young scientists in carrying out scientific, organizational, scientific and educational activities;

- promoting the development and improvement of the scientific sphere of Ukraine and its integration into the world and European research space" [2].

There is no doubt that young scientists can actively cooperate with any type of non-profit organizations in various activities. The most important thing in this case is to establish cooperation and effective communication. It can be concluded that the most important areas of young scientists' cooperation with non-profit organizations in line with solving young scientists' problems in the context of globalization are the following:

- Activities aimed at promoting young scientists;

- Holding joint scientific events (conferences, seminars, round tables, trainings, etc.);

- Voluntary work;
- International cooperation;
- Joint participation in projects and grants, especially international projects.

The above mentioned promising areas of cooperation of young scientists of Ukraine with non-profit organizations are not exhaustive. Cooperation should aim at solving or drawing public attention to the pressing problems of young scientists in order to find further solutions.
