ABSTRACT

Maryna Opanasenko. Modern trends and patterns of international population migration. - Graduation thesis on specialty 051 "Economics", OPP "International Economy". National Aviation University of the Ministry of Education and Science of Ukraine, Kyiv, 2023.

The thesis contains 69 pages, 6 tables, 1 figure, a list of used sources with 44 names.

The object of the study is the trends of international labor migration and the risks faced by migrants.

Considering the subject of research, it is possible to highlight ways of overcoming, conditions of formation and possible consequences of social risks for migrants.

The purpose of the article is to determine the main causes and trends and possible positive and negative consequences of this phenomenon on the basis of domestic and foreign statistical data and ongoing research on the current state of international labor migration.

The scientific novelty of the article lies in the comprehensive analysis of new statistical and demographic data regarding the unprecedented scale of the forced resettlement movement of 7 million within the borders of Ukraine and the forced emigration of almost 6 million of its inhabitants and the negative impact of these phenomena on the gene pool of our state.

When writing the work, research methods were used: analysis and synthesis, comparative and statistical methods. In the process of writing the qualification work, a lot of information was considered.

At the same time, free migration poses a danger to governments both from the point of view of political stability and from a social perspective.

Migration is a global phenomenon, the complexity, scope and impact of which are constantly growing. The complexity of the phenomenon itself, the multifactorial nature of its causes, and the ambiguity of the consequences of international labor migration make it necessary to develop an effective migration policy. If the policy of the receiving countries is aimed at regulating the level of immigration, encouraging the immigration of highly qualified workers, promoting the integration of migrants into the system of the receiving society, then the strategies in the countries of origin are aimed at regulating emigration, accepting dual citizenship, policies to stimulate the return of citizens, as well as measures to promote the involvement of the diaspora .

Traditionally, the economic cause of migration is identified as the main one, which is related to the pace, structure of accumulation and scale of capital. Therefore, this topic is quite relevant for research.

CONCLUSION

Consideration of migration processes as territorial movement is identified with the general term "movement" and "social mobility of units", during which not only interstate, but also socio-cultural borders are crossed. The choice regarding migration is a responsible choice of each potential migrant, which must be consistent with the life strategy and future plans of individuals.

The concept of migration is considered by the sociology of migration as a social process that includes spatial movement, readiness of a potential migrant to migrate and adaptation to a new environment. The formation of the concept of "potential migration" took place due to the identification of the individual's readiness for the migration process as a separate one, which is the result of the individual's realized and planned choice.

International migration for the purpose of employment cannot be considered only as a strategy of adaptation and adaptation to new, uncertain conditions, because an integral component of international labor migration is the possibility of self-realization of an individual and the disclosure of his professional potential. Thus, these conditions are necessary for the study of risks that appear in the process of international labor migration.

It is noted that every year the number of Ukrainian workers

of migrants is increasing. Ukraine is rightly considered one of the largest donors of labor resources. The problem is that our country does not keep statistics on the real number of Ukrainian citizens working abroad. There is also no real data on the volume of immigration.

This distorts the picture of migration processes in Ukraine, makes their effective regulation impossible.

Unfortunately, today the negative consequences of labor migration in Ukraine overshadow all the positive effects caused by migration processes: the demographic and

social situation in the country is deteriorating, the number of highly qualified workers is decreasing, migrants from our country, most of whom are illegal, are being exploited, etc.

Regulation of labor migrations should also be based on a differentiated approach and be aimed at the gradual return of labor migrants and the establishment of cultural relations with Ukrainians who have decided to stay abroad forever. It is necessary to provide conditions for the spread of legal employment, first of all, in those countries that receive the largest number of Ukrainian migrants. It is necessary to guarantee the protection of the rights of migrant workers.

If you do not take any measures to introduce the migration law policy, then the demographic vacuum created by the phenomenon of depopulation will be filled by immigrants, the level of social homogeneity, the criminogenic and security situation, etc. will deteriorate.

The main directions of the migration policy of the European Union are: reducing the number of illegal migrants, border management, general policy on asylum and legal migration.

Summarizing the above, we can conclude that Ukraine has a negative migration growth and a low level of socio-economic life. Every year, more and more people leave Ukraine, and a significant number of labor migrants mainly migrate to EU countries. The main problems of the large number of emigrants and the unattractiveness of the country for immigrants are the weak migration policy and the quality of life in the country. It does not have sufficient social protection for migrant workers, conditions for their work, and wages are not competitive with EU countries.

Therefore, the migration of the labor force of Ukraine is a complex and large-scale phenomenon that has covered the whole world and causes ambiguous results: eliminating the shortage of labor in some regions, it exacerbates competition on the labor market.
